CAUTION:

RACEREADY COMPLETE may be used either on untreated seed, or seed that has been treated with a fungicide or insecticide. Wear appropriate protective gear, avoid skin contact or breathing of dust, and follow the caution statements of the other treatments if the seed has been pretreated. Individuals allergic to molds and or fungi should take precautions to avoid contact with the eyes or skin. To minimize risk of allergic exposure, individuals should wear standard protective clothing and equipment including gloves, safety glasses, and an NIOSH approved respirator. In case of allergic contact with eyes or skin, immediately flush the exposed area with water. Seek medical attention if irritation develops or persists.

FIRST AID

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF IN EYES: Hold eyes open and rinse slowly and gently with water for 15-20 minutes. Remove contact lens, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have the person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

WARNING:

FIRST AID

NOTES:

- Avoid inhalation of treated grain dust.
- Exposed treated seeds may be hazardous to birds and other wildlife. Dispose of all excess treated seeds and seed packaging by burial away from bodies of water.
- Seed treated with this product does not flow as freely as untreated seed. Make adjustments to compensate for this restricted seed flow to prevent lower than desired seeding rates.
